

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Soldiers from Fort Hood have been and continue to be
2 deployed as part of Operation Enduring Freedom; and

3 WHEREAS, These troops join other Texas army and air force
4 personnel who have been assigned to this operation, including those
5 from Fort Bliss, Fort Sam Houston, Dyess Air Force Base, and
6 Lackland Air Force Base, as well as members of National Guard and
7 reserve units throughout the state; and

8 WHEREAS, American citizens owe an immeasurable debt to their
9 military personnel, whose efforts have secured this nation's
10 treasured liberties and made it the greatest country in the world;

12 WHEREAS, At this time of grave crisis, we recognize these men
13 and women and their families for the tremendous sacrifices they
14 make in behalf of their country, and we encourage the communities in
15 which they live to offer them understanding and support during this
16 hour of world concern; now, therefore, be it
