

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Tarrant County extension agent Hurley E. Miller has
2 been named the recipient of a 2002 Superior Service Award, the
3 highest honor given by Texas Cooperative Extension to a member of
4 its faculty or staff; and

5 WHEREAS, Mr. Miller currently serves as county extension
6 agent for 4-H and youth development in Tarrant County; under his
7 direction, the 4-H program has grown from 19 to 24 clubs, while
8 membership and total participation have also increased
9 significantly; and

10 WHEREAS, Among Mr. Miller's successful projects are Teens
11 Learning Leadership, an eight-week leadership development course,
12 and One Homeless Night, a nationally recognized service learning
13 project to raise community awareness about the homeless; and

14 WHEREAS, Mr. Miller has also served with distinction in
15 numerous professional leadership positions; president of the Texas
16 Association of Extension 4-H Agents, he has represented Texas at
17 the national agents' meeting, the Southern Region Leadership
18 Conference, and the national Public Issues Leadership Development
19 Conference in Washington, D.C.; and

20 WHEREAS, On February 7, 2003, the Texas Legislative Black
21 Caucus presented Mr. Miller with an Outstanding Texan Award for his
22 exemplary work within the community; and

23 WHEREAS, The 2002 Superior Service Award honors him for his
24 outstanding achievement and personal commitment in serving Tarrant

1 County youth and extension colleagues through educational efforts
2 in leadership development; it represents the esteem in which he is
3 held by his colleagues, and it is a pleasure to join with them in
4 commending Mr. Miller for a job well done; now, therefore, be it

5 RESOLVED, That the 78th Legislature of the State of Texas
6 hereby congratulate Hurley E. Miller on receiving a Superior
7 Service Award from Texas Cooperative Extension and extend to him
8 warmest wishes for continued success and happiness; and, be it
