

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Memories of a life filled with many joyful times and
2 meaningful accomplishments may comfort the family and friends of
3 Dorothy Turner Scharbauer of Midland, who passed away on February
4 23, 2005, at the age of 73; and

5 WHEREAS, Born on March 9, 1931, to Fred Turner, Jr., and
6 Juliette Miller Turner, in Midland County, Mrs. Scharbauer
7 graduated from Midland High School, and attended the University of
8 Colorado at Boulder and Christian College in Columbus, Missouri;
9 she married Clarence Scharbauer, Jr., on August 27, 1949, and
10 became the proud mother of four children; and

11 WHEREAS, Mrs. Scharbauer, a descendant of a Midland oil
12 family, was known for raising champion Thoroughbreds at Valor Farm,
13 a 400-acre facility; in 1987, Alysheba, a Thoroughbred co-owned
14 with her daughter, won the Kentucky Derby and the Preakness Stakes;
15 the following year, he won the Breeder's Cup Classic and was named
16 the Horse of the Year in Thoroughbred racing; two of her stallions
17 also topped the Texas Thoroughbred Association's list of leading
18 sires in the state for 2004; and

19 WHEREAS, A true community leader, Mrs. Scharbauer was an
20 active supporter of the Museum of the Southwest at Turner Mansion,
21 which was her childhood home; furthermore, she and her husband made
22 substantial contributions to Midland College, including \$1 million
23 to the Chaparral Circle Endowment Fund; to honor the couple, the
24 school named a recently restored facility the Dorothy and Clarence

1 Scharbauer, Jr., Student Center; and

2 WHEREAS, An active member of First Presbyterian Church, the
3 National Society Magna Charta Dames, Midland Memorial Hospital
4 Auxiliary, and the Junior League of Midland, she was known for her
5 extraordinary support for people and organizations in need; and

6 WHEREAS, Dorothy Scharbauer was a quietly elegant woman, and
7 with her grace and generosity made the city of Midland a better
8 place to live; she will be deeply missed by her friends, family, and
9 all those who were privileged to have been touched by her kindness;
10 now, therefore, be it

12 hereby pay tribute to the life of Dorothy Turner Scharbauer and
13 extend deepest sympathy to the members of her family: to her
