

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, On February 28, 2005, dignitaries and citizens from
2 the city of West, Texas, are coming to the State Capitol in Austin
3 to share their Czech heritage, hospitality, and world-famous
4 kolaches; and

5 WHEREAS, Established at its present site in 1881 and
6 officially becoming West nine years later, this small but vibrant
7 community--named after Thomas West, a farmer, postmaster, and
8 businessman--retains many of the same charms that drew people to
9 the area more than 100 years ago; and

10 WHEREAS, Among those drawn to this rich farmland were
11 immigrants from Czechoslovakia, who came to the area, farmed the
12 land, opened businesses, shared their European culture, and planted
13 roots that are now indelibly woven into the identity of West; and

14 WHEREAS, The people of West embrace this heritage, making it
15 known and officially designated as the Czech Heritage Capital of
16 the State of Texas and offering the yearly Labor Day weekend
17 tradition of Westfest, a celebration of Old World foods, music,
18 arts and crafts, and many other activities; and

19 WHEREAS, Among the many charms of West that make it a must for
20 countless travelers, perhaps the most favorite and famous are the
21 delicious fruit and meat kolaches, brought to the State Capitol on
22 this day by the Catholic Daughters in West; now, therefore, be it

23 RESOLVED, That the 79th Legislature of the State of Texas
24 hereby declare Monday, February 28, 2005, as West Day at the Capitol

1 and express its deepest gratitude to the people of West, who have
2 come to the Capitol to share the things we all love most about
3 West--its rich history, its hospitality, and its food; and, be it
4 further

5 RESOLVED, That an official copy of this resolution be
6 prepared for the city of West as an expression of high regard by the
7 Texas House of Representatives and Senate.
