

1 subject to Section 2252.901, Government Code. Each teacher shall
2 be employed under a term contract as provided by Subchapter E,
3 Chapter 21, or under a probationary contract as provided by
4 Subchapter C, Chapter 21. An employee employed under a contract
5 under this subsection:

6 (1) shall be paid in accordance with a salary
7 structure adopted by the superintendent with the concurrence of the
8 board that provides salaries, including assignment stipends,
9 equal, on a daily-rate basis, to salaries, including assignment
10 stipends, paid to employees employed in comparable positions by the
11 Austin Independent School District;

12 (2) is not eligible for longevity pay under Subchapter
13 D, Chapter 659, Government Code, and is not entitled to a paid day
14 off from work on any national or state holiday;

15 (3) is eligible for sick leave accrual under the
16 General Appropriations Act in each month in which at least one day
17 of the month is included in the term of the employment contract and
18 in any other month in which work is performed or paid leave is
19 taken;

20 (4) may be permitted by the board to take paid time off
21 from work during the term of the employment contract for personal
22 reasons as designated by the board, but the paid time off may not
23 exceed three days per contract term and may not be carried forward
24 from one contract term to a subsequent contract term;

25 (5) may be permitted by the board to be paid the salary
26 designated in the employment contract in 12 [~~equal~~] monthly
27 installments; and

1 (6) shall work the hours established by the
2 superintendent [board].

3 (g) The school may pay to a teacher or employee who provides
4 services or supervises an employee who provides services as
5 described by Subsection (b) and who is employed in a supplemental
6 program under Section 30.021(c) a salary that, on a daily-rate
7 basis, does not exceed the salary paid by the Austin Independent
8 School District to an employee employed in a comparable position
9 during the regular school year.

10 SECTION 4. This Act takes effect immediately if it receives
11 a vote of two-thirds of all the members elected to each house, as
12 provided by Section 39, Article III, Texas Constitution. If this
13 Act does not receive the vote necessary for immediate effect, this
14 Act takes effect September 1, 2005.
