AN ACT

relating to the eminent domain power of certain municipal management districts.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter C, Chapter 3801, Special District Local Laws Code, as effective April 1, 2005, is amended by adding Section 3801.107 to read as follows:

Sec. 3801.107. NO EMINENT DOMAIN POWER. The district may not exercise the power of eminent domain.

27 SECTION 21. Chapter 777, Acts of the 78th Legislature,

3 Sec. 18A. NO EMINENT DOMAIN POWER. The district may not  
4 exercise the power of eminent domain.

5 SECTION 22. This Act takes effect immediately if it  
6 receives a vote of two-thirds of all the members elected to each  
7 house, as provided by Section 39, Article III, Texas Constitution.  
8 If this Act does not receive the vote necessary for immediate  
9 effect, this Act takes effect September 1, 2005.






