5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subsection (b), Section 2166.305, Government  
7 Code, is amended to read as follows:

8 (b) A committee appointed by the commission shall perform  
9 the review. The committee consists of:

10 (1) the director of facilities construction and space  
11 management appointed under Section 2152.104, who serves as the  
12 presiding officer of the committee;

13 (2) six [~~seven~~] individuals appointed by the  
14 commission, one each from the lists of nominees submitted  
15 respectively by the:

16 (A) president of the Texas Society of Architects;

17 (B) president of the Texas Society of  
18 Professional Engineers;

19 (C) presiding officer of the Executive Council of  
20 the Texas Associated General Contractors Chapters;

21 (D) executive secretary of the Mechanical  
22 Contractors Associations of Texas, Incorporated;

23 (E) executive secretary of the Texas Building and  
24 Construction Trades Council; and

1 (F) president of the Associated Builders and  
2 Contractors of Texas [~~and~~

3 [~~(C) executive director of the National~~  
4 ~~Association of Minority Contractors, with the list composed of~~  
5 ~~persons who reside in this state];~~

6 (3) one individual appointed by the commission  
7 representing an institution of higher education, as defined by  
8 Section 61.003, Education Code;

9 (4) one individual appointed by the commission  
10 representing a state agency that has a substantial ongoing  
11 construction program;

12 (5) one individual appointed by the commission  
13 representing the attorney general's office; [~~and~~

14 (6) one individual appointed by the commission  
15 representing the interests of historically underutilized  
16 businesses; and

17 (7) two individuals appointed by the commission, each  
18 representing a different minority contractors association.

19 SECTION 2. This Act takes effect September 1, 2007.
